- At the end of their papers, they should include a list of References.

Authors should use one of the standard systems of referencing (e.g., APA; CMS; MLA) appropriate to the discipline in which they are writing.

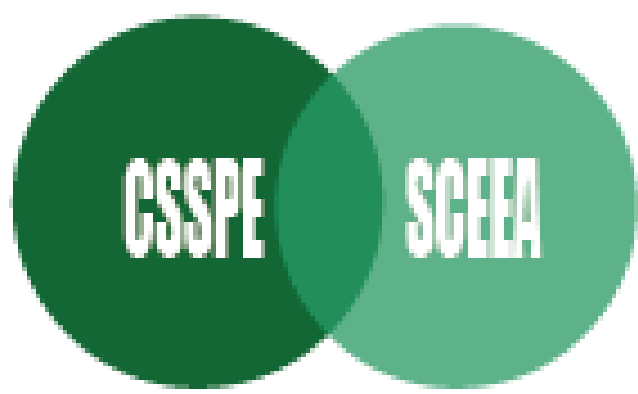
